Dear Member:

In accordance with Article XVIII, Section 3 and 8(d), of the LIUNA International Union Constitution, monthly dues will be increased by two dollars (\$2.00) per month, effective January 1, 2023. Therefore, quarterly dues for 2023 will be **\$246.00 PER QUARTER**.

NOTE: ASIDE FROM THIS NOTICE, WE ARE NOT MAILING OUT "REMINDER NOTICES" ON QUARTERLY DUES. PLEASE KEEP CALENDAR FOR YOUR RECORDS. ALSO, PLEASE MAKE SURE WE HAVE YOUR CORRECT CELL PHONE NUMBER AS WE WILL SEND "ROBO-TEXT" DUES REMINDERS.

* **DISABILITY DUES:** A member may apply for disability dues (\$132/quarter) if he/she has been out of work and under a doctor's care for a full three (3) months. Beginning the first day of the fourth month of disability, the member will be allowed to go on "Disability Dues" provided the member has completed a "Disability Form", as provided by Local 724, and includes a "Doctor's Disability Note". Disability dues will NOT be retroactive.

LOCAL 724 UNION DUES - QUARTERLY DUE DATES - Effective 1/1/2023

*Union Dues amount may change, but the DUE DATES will ALWAYS REMAIN THE SAME

***Note: If the last day of the month falls on a Saturday, Sunday, or Union Holiday, Union dues will be due in our office on the FRIDAY/WORKDAY PRIOR to the weekend/holiday.**

1ST QTR DUES - \$246.00

January - March

\$246.00 due on January 1st
\$256.00 due if paid/post-marked after Jan 10th
\$266.00 due if paid/post-marked after Feb 10th
\$266.00 must be received in Union office by **2/28** by 5pm to avoid **SUSPENSION** on March 1st.

2ND QTR DUES - \$246.00

April - June

\$246.00 due on April 1st
\$256.00 due if paid/post-marked after April 10th
\$266.00 due if paid/post-marked after May 10th
\$266.00 must be received in Union office by **5/31** by 5pm to avoid **SUSPENSION** on June 1st.

***May 29th is Memorial Day/Union Holiday**

3RD QTR DUES - \$246.00

July - September

\$246.00 due on July 1st
\$256.00 due if paid/post-marked after July 10th
\$266.00 due if paid/post-marked after August 10th
\$266.00 must be received in Union office by **8/31** by 5pm to avoid **SUSPENSION** on September 1st.

4TH QTR DUES - \$246.00

October - December

\$246.00 due on October 1st
\$256.00 due if paid/post-marked after Oct 10th
\$266.00 due if paid/post-marked after Nov 10th
\$266.00 must be received in Union office by **11/30** by 5pm to avoid **SUSPENSION** on December 1st.
